## **7.0 STANDING REPORTS**

### **7.2 Department Fire and Emergency Services**

Craig Garrett spoke to the following:

- The State Bush Fire Exercise is to be conducted on 17 October 2017 in various locations.
- Western Australian Fire & Emergency Services Conference will be held on 8-10 September 2017 at the Perth Convention & Exhibition Centre
- DFES are currently running a Wintersafe media campaign focussing on winter storms and home fire safety.
- Regional staff will be inspecting UCL/UMR lands regarding mitigation works required for the fire season.
- Jamie O'Neill has been employed as CESM Mundaring and CBFCO.
- An ICV exercise to be conducted on 26 August 2017 at WA FES Academy, with Darling Range BFB to attend.
- The 2017 Volunteer Employer Recognition Awards(VERA) nominations still open until the end of August.
- The Mundaring Rural Urban Interface(RUI) Exercise to be conducted on 21 October 2017, with local and neighbouring brigades.
- Thanks to the outgoing Brigade officers and office bearers, and congratulations to those people taking up new roles.
- DFES are currently undertaking a project to replace the Computer Aided Dispatch (CAD) system, which is used to dispatch resources for emergencies state wide.
- Vehicles are undergoing Comprehensive Crew Protection fit outs and Brigades are reminded to leave all equipment /stowage on vehicles as they must be weighed prior to and after completion of works to ensure the vehicle is legal.

Jamie O'Neill

Thanked brigades for making him feel welcome in his new role, saying that if Brigades have any events or would like him to visit the station to please be in touch.

Advised the meeting that a high season appliance application has been submitted for approval for the Darlington brigade for the 2017/2018 season.

Recent feedback from DFES workshops on the condition of the Glen Forrest and Parkerville light tankers recently returned was not good, after their inspections an unusual number of defects were reported that should have been rectified prior to the vehicles being returned to DFES.

Reminder to brigades that it is essential that any damage to vehicles is immediately reported and repaired. All Brigades and the Shire are responsible to ensure that all appliances remain in good repair and are road worthy.

Advised that Fuel Card Scheme is once again available, with application via the volunteer portal (link sent to all brigades on 16 August 2017)

### **7.4 Mundaring Fire School/Training Officers Committee**

Neil Hawkins : As this is my first report as Local Government Fire Training Coordinator, I should start by thanking my predecessor. John Duff has been a fixture in Mundaring Fire Training for more than twenty years and I thank him for his support and guidance and wish him a happy retirement (though I know he will still be around!)

#### **Mundaring Firefighters School**

The Mundaring Firefighters School, to date this year has scheduled thirty-four training courses, but has had to cancel six, three due to a lack of nominations and the others due to a lack of qualified Instructors, due mostly to Mark Casotti's departure. The lack of nominations earlier in the year is a concern, and we are attempting to determine if there are any specific reasons we can address. Despite the slow start we have trained more than 220 students so far, with only seven 'no shows' who have been referred back to their brigades. The school has welcomed three new members, and three instructors have received additional trainer/assessor endorsements.

Since the AGM we have a new Secretary, Jana Mackowiak, and a new Treasurer, Heather Curley, and I took over as the Deputy Chairman. Thanks to Bill Cowe for his long service as secretary/Treasurer.

Finally, Sue Smith is heading a small working group to review the Fire School Constitution over the next few months to ensure that it is fully compliant with the Associations Incorporation Act 2015 and our administrative needs.

#### **Shire Training Officers Committee**

The Training Officers Committee remains active with good representation from all Brigades. The committee has completed the firefighter skills refresher document which has been submitted to BFAC for endorsement, in addition we have tabled two additional skills refreshers, one for the ICV crew, the other for the Collar Tank/Fire Support Crew. Whilst there is still reticence in some brigades the skills refresher is an important process for us to ensure that firefighters have the necessary skills to operate safely and effectively and the TOC encourages the BFAC to endorse the content so that brigades can begin working through it (though many are already undertaking skills

refreshers based on these or previous drafts). At their last meeting, the TOC received training in the use of eAcademy from Darlene Hatherley, the DFES Regional Training Coordinator; Darlene also gave us an insight into some of the potential enhancements to the system expected later this year. This resolved some of the issues that have previously caused frustration, but members are encouraged to 'play' and explore the software as familiarity only comes through practice.

A concern has been raised by Brigades regarding the way that Driver Training has been conducted this year. Brigades were offered six training places over a single weekend, which some feel has been difficult to schedule, especially for some members who are fly-in/fly-out. The suggestion is to perhaps have three people one weekend, then a further three on a different weekend. This would also allow brigades to share vehicle use so that each brigade only loses their light tanker for one day each training weekend. Additionally, we have been asked about the possibility of getting the Mundaring specific courses (ICAW, Practical Crew Leader, Prescribed Burning, etc.) to show under a member's eAcademy records so that BTO's can highlight training opportunities or suitable refresher training more easily. It is my understanding that we can get the records added to eAcademy as "external" training, but there would need to be an efficient process for this to be entered. To fulfil the role of LGFTC more efficiently, and to assist BTO's I would like to apply for wider (coordinator – read only) access to eAcademy so that I can review future course nominations and training records across the Shire. I have been told that this is possible, but I need to have my role as LGFTC placed on my RMS records with DFES and authorisation from the Shire to access the records.

**Summary of Actions Requested:**

1. BFAC endorse the Skills Refresher process and forms tabled by TOC
2. BFAC support the need for flexibility in the provision of Driver Training
3. BFAC support the LGFTC in investigating if Mundaring Firefighters School Course results can be recorded in eAcademy
4. BFAC endorse the need for additional access to eAcademy for the LGFTC.

In closing I thank the TOC for giving me the opportunity to take on the LGFTC role and look forward to working with BFAC and all brigades to improve training across the Shire. Please don't hesitate to contact me if there are any fire training related questions or concerns.

A discussion was held regarding having the records for Mundaring specific courses added to eAcademy. It was agreed that this could be done (manually) with Craig Garrett and Jamie O'Neil to follow up with the DFES eAcademy administrator.

A discussion was held around Driving under Emergency Conditions with it being noted that the reference to DFES 3.3.1 will be removed from Shire Directive 7.1.
