#### 5.0 **PRESENTATIONS**

#### 5.1 **CESM Mundaring/Chief Bush Fire Control Officer**

Jamie O'Neill thanked Daniel Heptinstall for acting in the CESM position while he was Acting Area Officer Kimberley - East. Jamie O'Neill told the meeting that he had been at a CESM Forum from 28 & 29 October 2019 and would make contact with Brigade Captains during the coming weeks.

#### 5.2 **Department Fire and Emergency Services**

- Mitigation works in Mundaring Shire have been awarded with works commencing on the second week in September.
- DFES's Bushfire Risk Management Officers have been burning in the Shire. A snake bite occurred to a District Officer that was lighting in the core of one of the burns.
- ICV reference group has held it's first meeting. The group is working on the process for working towards forming a State Wide ICV User Group ( SWICVUG) and identifying the Terms Of Reference, Scope of Work and the inception of the SWICVUG at the next meeting scheduled 18th October.
- IRIS and the lack of incident information and appreciation for DO's, CESM's and Volunteer crews since it's been introduced.
- AVL testing not being carried out by all Brigades.
- Operational Fleet Project coming to an end ( 20<sup>th</sup> of December)
- VTAG meeting schedule before the end of the year.
- Handhelds and box radios for the Mundaring fire school are progressing
- Launch of the Volunteer Hub end of October

Jeff Bromilow asked Murray McBride about IRIS and how it would be rolled out to volunteers. Mr McBride said that it would be approx. 2 years before IRIS was rolled out to volunteers.

#### 5.3 **Department Parks and Wildlife**

#### 5.4 **Mundaring Fire School/Training Officers Committee**

Formal training run at the school since the last BFAC includes:

- Incident Controller (Level 1) (17 August) Cancelled;
- Advanced Bush Fire Firefighting (24 August) 15 students;
- Crew Leader Bush Fire (25 August) 17 students;
- Introduction to Firefighting (14 September) 5 students;
- Bush Fire Firefighting (21 September) 9 students, 1 cancellation;
- Structural Firefighting (5 October) Cancelled;
- Mundaring Practical Crew Leader (12 October) 7 students.

Upcoming training includes:

- Introduction to Firefighting (26 October) 6 applicants;
- Bushfire Fire Fighting (2 November) 5 applicants;
- Sector Command (9 November) 10 applicants;
- WAREN Basic (23 November) 3 applicants;
- WAERN Advanced (23 November) 3 applicants;
- Fire Control Officer (23 November) 15 applicants;
- Initial Control at Wildfire (23 November) 8 applicants.

At the last MFS meeting Adrian Dyson showed the members around the Stoneville Play Group building which has been proposed as an alternative location for the school as part of the redevelopment of the current site. All members saw value in the proposal as an interim solution pending stage 2 development which would potentially include an extension to the current building and the addition of resources to assist with training.

Ricky Curtis, the new AC Learning & Development has advised that the new bushfire training modules are due to be released in the new year, we are awaiting further information to determine how they will be packaged and rolled out so we can create our 2020 Calendar. This will coincide with the release of eAcademy 2.0 an improved

It is likely that we will still schedule full weekend bushfire training at MFS covering multiple modules, however there may be some flexibility for brigades to run the individual modules on-station. We will advise as soon as we know more.

# 5.5.1 Brigade Fire Reports

Adrian Dyson told the meeting that he had recently been asked to provide some data/statistics on Shire of Mundaring brigades who had attended the Horton Road Incident in May of this year. The reports on records at the Shire did not reflect the number of brigades who had attended the incident.

Combined Stoneville Volunteer Bush Fire Brigade/MFS Facility Proposal

Adrian Dyson advised that the use of the former Stoneville Playgroup had been approved for use by Council for the Mundaring Fire School as part of a staged development. Meetings with draftsmen and builders will commence in the coming weeks to determine modifications needed to have the building comply with BCA requirements.

It is anticipated that the new Stoneville Station will be built on the existing location with funding to be sourced from DFES, (via the ESL/LGGS) and Shire contribution.

#### (ii) **BRMP** Update

Adrian Dyson said that he will present a business case to the Corporate Business Plan to have a dedicated human resource to manage the MAF Funding and coordination of works to be carried out. Adrian said he hopes that he BRMP/MAF project is not a "one of" government spend as what is mitigated in one year, will need to be again mitigated in future years, i.e. a "never ending" project.

A discussion was held around community notification/consultation around works being carried out in their local area, with Murray McBride saying that a fortnightly report will be sent to the CESM and Manager Community Safety & Emergency Management for distribution to brigades and shire communications. Similarly Adrian Dyson also gave an undertaking that regular advice would be distributed to brigades in relation to Shire reserve MAF works.

#### SUMMARY

The Captain, Mount Helena Voluntary Bush Fire Brigade has submitted a request for BFAC to recommend to Council that Permits To Set Fire To The Bush (Permits) issued to residents be issued covering a 14 day period, as against the 7 day period that currently applies.

This report recommends that the Committee recommends that Council endorses that the existing period of time applicable to a permit isued to a resident remain as currently applies, being 7 days.

#### **BACKGROUND**

The existing 7 day Permit period has been in place since 2016 and was instituted upon the recommendation of the then Chief Bushfire Control Officer, Mr Mark Casotti for the principal reason that beyond 7 days there is a degree of uncertainty as to the expected fire weather conditions and thus the risk of a resident conducted hazard reduction burn becoming out of control or escaping is unacceptable.

The following table lists permit durations for six other local governments with similar rural urban interface environments.

Local Government	Permit Duration & Comments
City of Swan	7 days, may issue for 14 days under specific conditions
City of Armadale	14 days
Shire of Northam	7 – 14 days (dependent on fire weather)
Shire of Kalamunda	14 days
Shire of Serpentine Jarrahdale	Town 1-2 days, Rural up to 4 days
City of Wanneroo	14 days (will reduce to 7 days dependent on fire weather)

#### **EXTERNAL CONSULTATION**

Consideration of this report will bring about consultation with Shire Volunteer Bush Fire Brigades.

#### COMMENT

Mt Helena VBFB Captain Brenden Scott's stated reasons for requesting that change for permits from 7 to 14 days are outlined within the copy of the email dated 5 August 2019 as per attcahment 1.

Mr Scott suggests that upon the occurrence of a Total Fire Ban (TFB) or Very High Fire Danger Rating (VHFDR) that brigades (having a record of permits that thay have issued) can contact permit holders to suspend such permits. It is understood that it is the current VBFB practice to contact permit holders to suspend a permit should other adverse fire weather conditions (eg late warning of high winds, high temepratures etc.) outside of a TFB or VHFDR occur.

While permit holders have a responsibility to only set fire to the area covered within the permit if it foreseen to be safe to do so the permit issuing system should be structured to minimise the requirement for VBFB Officers to contact permit holders if an unforeseen adverse change in fire weather is imminent. The probability for the requirement for such contact to be made by VBFB Officers is increased if permit durations go beyond the usual 7 day span of reliable weather forecasting.

It is noted that the electronic Fire Danger Rating boards will allow for messaging such as PERMITS CANCELLED etc. should conditions warrant same. In addition Shire of Mundaring is considering usage of Telstra Instant Messaging System (TIMS) which could be used to notify subscriber pemit holders of a requirement to suspend permits.

In relation to Mr Scott's suggestion that the permit form include tick boxes around VHFDR and a requirement for the permit holder to telephone the Shire fire information daily message, it is noted that the form includes some textural/referencing errors. The Committee view in relation to a revised permit form template is sought.

A discussion was held, with Jamie O'Neill reminding the meeting that an FCO can alter (by hand and signing changes) the time period of a permit from 7 to 14 days, reminding the meeting that the FCO who does so, is responsible.

Brigades will be given the opportunity to provide the Shire with feedback on how some improvements, such as tick boxes can be made to permits in time for the next Restricted Burning Period.

#### 7.0 **URGENT BUSINESS (LATE REPORTS)**

Adrian Dyson gave the meeting a brief update on the Shire's concerns around its two structural brigades and the use of BA, saying that a letter had been written to Garry Baxter requesting that both Mt Helena and Parkerville brigade have quarterly checks carried out by DFES around all training and the use of structural BA, with DFES confirming that this will be implemented.

Adrian Dyson said that the Australia Fire Danger Rating system is being reviewed with one of the ratings (Catastrophic) to possibly be removed.

Adrian Dyson advised that DFES are reviewing he current Emergency Services Acts to create a single Act.

Craig Cuthbert said that Firebreak compliance season will commence on 1 November 2019 and asked that if brigades are approached by residents for advise that it be in line with Shire's Firebreak and Fuel Load notice.

Permits to set fire to the bush

Hi Adrian,

I forgot all about sending you an email.

As per my request at BFAC to extend the permits from 7 to 14 days here is the reasons behind it.

We like many other brigades get the same residents coming down every Saturday to get their 1 to 3 piles at 1m² for a week at a time. We also get numerous FIFO people as well. By extending the permits from 7 days to 14 days would reduce the amount of time our residents have to come down to the station. If the conditions permit we should be allowed to issue them for 14 days at a time. If the conditions are dry/windy we should limit the permits to 7 days only. I would like to see permits issued for a month in line with many of the other shires, but I know that is not going to happen. All brigades keep a record of permits issued and there is no issue in contacting people if there is a TFB or VH FDR to suspend permits.

Over the years since I have been issuing permits I have had many residents ask why they can't get a permit for more than 7 days. My typical response to them is either write a letter to the brigade, or write one to the shire. Majority of people go that is too hard. I have received one email from a resident which I will forward onto you.

I would also like tick boxes for Very High FDR and one to ring the shire fire weather hotline. Most people don't read the writing yet they read the tick boxes. Go figure, but that is what I have been questioning as well in the past 12 months. You can then remove the writing about VH FDR and shire hotline and just have tick boxes.

Also just so you know I am off on Sunday, returning in the 1st week of October. Daniel will be in charge of the brigade while I am away.





## **Training Programs Principles**

Training Programs are a role-based training framework designed for progressive and safe training.

Training content is designed to be delivered in a flexible manner, either as a full course delivered over a weekend or, depending on the course, modularised and delivered over a timeframe that better suits the local environment.

A Training Program may include Training Streams related to specific response or capability roles, such as Pump Operator or Advanced Bush Firefighter. Within each Training Stream there are one or more required courses, which must be completed to complete that Training Stream. You may participate in more than one Training Stream simultaneously.

The Training Streams are designed to provide:

- Ease of targeting brigade profile requirements
   Be easy for Brigades, Local Governments and DFES Regions to target brigade training needs
- Flexibility
   Allow volunteers more flexibility in their training; and
- Choice
   Be easy to understand and complete.

You are encouraged to complete the Bush Firefighter Training Program and the Advanced Bush Firefighting Training Stream prior to enrolling on any of the BFB Leadership Training Stream courses.

## Training Programs Entry

You will automatically be enrolled on the Bush Firefighter Training Program, once you have completed a volunteer membership application, an induction relevant to your Brigade/Local Government and have a DFES volunteer number.

#### Training Prerequisites

DFES and the Association of Volunteer Bush Fire Brigades WA acknowledge that it is better that volunteers complete the courses in the specified order; however, course cancellations do happen and can affect a volunteer's attempts to complete a Training Program or Training Stream.

Volunteers can complete courses within specific Training Streams out of the specified order, unless otherwise illustrated in the Training Program with an arrow Completion Requirements

To complete the Bush Firefighter Training Program, you will need to complete all the courses listed on the Training Program. Training Programs Progress - Next Steps

Once you have completed the Bush Firefighter Training Program Training Program, you will be automatically enrolled on the Advanced Firefighter Training Program.
