### SUMMARY

The Environmental Art Project (EAP) is a long running environmental education initiative with a different theme each year.

It is recommended that the EAC endorse an environmental volunteer focussed theme for the 2023 EAP, 'Helping Hands'.

### **BACKGROUND**

The EAP is an annual program delivered in partnership with the Mundaring Arts Centre. It is centred around an environmental drawing competition and exhibition for local primary school students. Each year, classes and students can investigate the environmental or sustainability theme, then develop their ideas into an A4 artwork. Focus questions and pages of resources are provided to assist schools, teachers and students to participate.

A professional artist assists the winning students to adapt and paint their design onto a banner to be displayed in the town centre. After a year, the banners are returned to the students as the new designs are installed.

The banners currently displayed in the Mundaring town centre are from the 2021 theme, Caring for Country. The current year's theme is Backyard Biodiversity, with entries open until 17 October 2022. Previous themes have included Life in the Leaf Litter, Plastic Waste and Recycling, Clean Energy, and Things with Wings.

### **EXTERNAL CONSULTATION**

Mundaring Arts Centre staff were consulted and are very supportive of the theme. Confirming the theme in advance allows more time for the Mundaring Arts Centre to seek grants and additional funding to support the project and deliver more related activities.

City of Swan often adopt the theme developed by the Shire of Mundaring to promote to schools within their area. This year the proposed theme and title were developed in collaboration with City of Swan staff, who are strongly supportive of recognising the contributions of environmental volunteers.

### COMMENT

The Shire has a long history of supporting environmental volunteers in Friends Groups and Catchment Groups working to restore natural areas. These groups have raised the issue of recruiting new volunteers, and particularly younger volunteers, to continue their work as older members retire from groups or move away.

Other types of environmental volunteering that could be included in the material developed for schools are wildlife carers, volunteers making nest boxes, and volunteers sorting donated materials to support reuse (minimising waste and environmental impacts).

As well as helping look after the environment, volunteering also has benefits for the volunteers themselves:

- · Learning new skills and building confidence
- Having fun whilst giving back to the community
- Feeling valued and part of a team
- Taking concern about the natural environment and turning it into practical local action can reduce anxiety
- Meeting new people and feeling more connected to the local community, as well as the natural environment.

The theme of 'Helping Hands' would provide broader recognition of the important contributions made by our current environmental volunteers, and hopefully encourage future volunteers.
