#### COMMENT

This policy, following feedback from the Governance Committee, has been broadened to include all emergency services operating within the Shire of Mundaring. This will see the inclusion of the Mundaring Volunteer Fire and Rescue Service and the State Emergency Service - Mundaring Unit, ensuring a consistent and inclusive approach to the recognition of service across all local emergency services. This will see the name of the policy changing to *'Emergency Services Life Membership and Outstanding Service Award'*.

Additionally, the policy will be updated to provide clearer guidance on the relationship between Long Service Awards and Life Membership, addressing feedback received throughout the review process.

Another notable change is the adjustment to the composition of the selection panel for these awards. In line with other Shire policies/committees requiring a panel, the number of panel members will be reduced to four. This will assist in maintaining consistency, fairness, and good governance in the assessment of nominations.

As part of these updates, a formal nomination form (**Attachment 3**) has been developed to provide a clear, consistent process for submitting and assessing nominations. A Declaration of Interest form (**Attachment 4**) will also be introduced to support transparent and impartial decision-making throughout the selection process.

#### 1. PURPOSE

To recognise members of the Shire of Mundaring Emergency Services for their hard work, dedication and commitment to the Shire of Mundaring and its community.

#### 2. SCOPE

This policy applies to the granting of Life Membership and Outstanding Service Awards for members of the Emergency Services within the Shire.

#### 3.

. DEFINITIONS	
Emergency Service(s)	a Shire of Mundaring Volunteer Bush Fire Brigade (VBFB), Mundaring Volunteer Fire and Rescue Service (VFRS), or Mundaring State Emergency Services Unit (MSESU)
Member	a member is an individual who is an Active member or their brigade or unit (this excludes cadets)
Long Service	a combined or continuous period of fifteen (15) years of service within the Shire of Mundaring in an Emergency Service.
Life Membership	a meritorious award for meeting the requirements of Long Service.
Outstanding Service Award	Meritorious award given for exceptional dedication, commitment, and contribution to the Emergency Services and community within the Shire of Mundaring.
Panel	A panel convened (in accordance with section 4.2.4

#### 4. POLICY

#### 4.1. Life Membership

A Life Membership is to be granted to a person who has provided Long Service as a registered member of an Emergency Services brigade or unit within the Shire of Mundaring.

#### 4.1.1. Eligibility

Membership and active status are confirmed using the Shire and/or Department of Fire and Emergency Services membership record systems. Any service time accumulated with emergency services outside the Shire of Mundaring will not be considered for this award.

#### 4.1.2. Nomination Process

Nominations for this award should be submitted to the Shire in response to the official call for nominations. A completed 'Nomination Form' is required, including relevant details and a summary of the individual's service within the emergency services in the Shire of Mundaring.

#### 4.1.3. Presentation of Life Membership

Upon receipt of the nomination and confirming that Long Service has been achieved, the recipient will be awarded Life Membership to the Shire of Mundaring Emergency Services, along with a clasp and a certificate of appreciation signed by the Shire's CEO and President.

This award will be presented at the annual emergency services event. If the recipient is unable to attend, arrangements can be made for a Shire representative to present the award to them at an alternative time.

#### 4.2. Outstanding Service Award

Outstanding Service Awards may be granted where a Panel agrees (by simple majority) that a nominee has demonstrated outstanding service to the Shire of Mundaring Emergency Services.

#### 4.2.1. Eligibility

Outstanding service is considered to include, but is not limited to, the following by a member of an Emergency Service:

- a) Getting involved in community education and awareness activities.
- b) Helping to bring new members into the brigade or supporting existing members through mentoring or simple retention efforts.
- c) Showing leadership and skill during major incidents or emergencies.
- d) Assisting with brigade administration or helping with fundraising and grant applications.



- e) Leading or supporting training sessions for fellow brigade members, no matter how big or small.
- f) Taking part in local or wider committees and groups that support bushfire management.

#### 4.2.2. Nomination process

Nominations for this award should be submitted to the Shire following the official call for nominations. A completed 'Nomination Form' must be provided, including relevant details and a summary of the individual's service and contributions within the emergency services in the Shire of Mundaring.

Evidence may include items such as meeting notes, attendance records, incident reports, commendations, or examples of roles the nominee has taken on. Every contribution counts and helps us celebrate the real impact our emergency service volunteers make.

#### 4.2.3. Selection Criteria

Upon receipt of the nomination for an Outstanding Service award, the nomination will be forwarded to a Panel for review and endorsement. If the Panel is satisfied that the recipient achieves the criteria, they will receive a clasp and a certificate of appreciation signed by the Shire's CEO and President.

#### **4.2.4.** Panel Members (for Outstanding Service Awards only)

The Panel shall consist of:

- a) The Chief Bushfire Control Officer
- b) An elected member appointed to the Bush Fire Advisory Committee (BFAC) or Local Emergency Management Committee (LEMC)
- c) A Captain appointed to the BFAC (excluding the captain of the nominated person's brigade)
- d) A member of the Mundaring Volunteer Fire and Rescue Service (VFRS) or Mundaring State Emergency Service (SES) (Captain or Unit Manager)

Nominations will be assessed by email correspondence between panel members. The result of the panel members' decision and reasons will also be provided by email correspondence.

#### 4.3.4 DISCLOSURE OF INTEREST

All panel members are required to disclose any actual, perceived, or potential conflicts of interest to the panel, with the details of these disclosures to be provided in Appendix 2 after receiving the nominations.

# BUSH FIRE SERVICE – LONG SERVICE AND OUTSTANDING SERVICE AWARDS

#### **PURPOSE**

To grant awards and life membership to registered members of the Shire of Mundaring Bush Fire Service for:

- long service, and/or
- outstanding service to the Shire of Mundaring Bush Fire Service.

#### **POLICY**

Life membership of the Shire of Mundaring Bush Fire Service shall be granted to a person who has served as a registered member of any Shire of Mundaring Brigade or Brigades for not less than fifteen years.

The Shire of Mundaring Bush Fire Service Outstanding Service Award shall be granted to a person who has served as a registered member of any Brigade or any Brigades and who has, in the opinion of a selection panel of persons being members of the Bush Fire Advisory Committee (BFAC), given outstanding service to the Shire of Mundaring Bush Fire Service.

#### 1. LONG SERVICE

For the purpose of this policy Long Service of fifteen years is defined as follows:

- Fifteen years' service as a registered and active member of a Shire of Mundaring Bush Fire Brigade or Brigades,
- Such service need not be continuous but must aggregate to fifteen years.

Time accumulated in service to brigades outside of Shire of Mundaring will not be considered for this award.

#### 2. OUTSTANDING SERVICE

Outstanding service is considered to consist of, but not be limited to any of the following:

- Extensive participation in community education initiatives;
- Demonstration of leadership in the attraction and retention of brigade membership;
- Demonstration of leadership and skills in response to major incidents;
- Application of skills and leadership in brigade administration and financial growth;
- Demonstration of leadership and interpersonal skills in the training of brigade members; and/or
- Significant participation in and contribution to district, regional or state committees or agencies involved with the management of bush fire.

#### 3. OUTCOME

The Chief Executive Officer, on behalf of Council, will grant the Long Service Award and Life Membership in accordance with this policy upon receipt of a nomination from a brigade and confirmation of the length of service of the intended recipient.

The Chief Executive Officer will grant the Outstanding Service Award and Life Membership in accordance with this policy upon receipt of a nomination from a brigade and endorsed by the selection panel.

#### 4. SELECTION PANEL

The selection panel shall consist of:

- Chief Bushfire Control Officer:
- The two elected members appointed to the Bush Fire Advisory Committee;
- One employee appointed by the CEO; and
- One member of BFAC who is a Captain of a Shire of Mundaring Volunteer Bush Fire Brigade.
