SUMMARY

The 2018/19 Youth Engagement Partnership Fund budget is \$35,000. This is the first and only round of this grant for this financial year, with the full \$35,000 being available for allocation. Four applications were received with these requests totalling \$32,449.

The applicants are seeking funds to run a variety of programs and events such as a youth theatre group, arts program, youth services directory and sports program. All activities fall within the grant guidelines.

It is recommended that Youth Engagement Partnership Fund grants to the value of \$26,294 be awarded to the four applicants, with adjusted amounts as outlined in the attached. (Attachment 1).

BACKGROUND

The Youth Engagement Partnership Fund was developed to financially assist local community groups to deliver a range of events and programs for young people in the Shire of Mundaring. These events and programs are designed to meet identified need in the community and to deliver services and programs which align with the Youth Informing Strategy 2017-2022. This Strategy has guiding principles of youth connection, strengthening of strategic partnerships, focussing on skills development and enabling peer support opportunities.

• Eligible Community groups can apply for up to \$10,000.

In addition to meeting the selection criteria, the Grants Selection Committee, as outlined in the program guidelines, will also take into consideration:

- Partnerships, where two or more community groups will benefit directly from the project; and
- The equitable distribution of funds across the geographic communities of the Shire of Mundaring.

The Youth Engagement Partnership Fund provides the Shire with opportunities for positive promotion. The Grant Guidelines and Agreement outline the requirement, on the acceptance of funding, that the groups acknowledge the support they receive from the Shire of Mundaring. This helps residents understand one of the ways Shire revenue is spent in the local community. It may also encourage other community organisations undertaking similar activities to consider approaching the Shire for a grant. The types of promotion include:

- Provide a written invitation to a Council representative to attend the project launch.
- Publicise the Shire's financial support for the project through:
 - At least one media article;
 - The Shire's name or logo on any promotional or program material produced for the event;
 - o The display of Shire of Mundaring signage during the event; and/or
 - Verbal acknowledgement of the Shire's support during speech activities.

The Youth Engagement Partnership Fund was promoted in the community through advertisement in the local newspaper, Shire website, community group email network, social media and posters at Shire sites and community noticeboards.

The four applications to be considered by the Committee are as follows:

All applications have been reviewed by the Youth Advisory Group (The Youth Crew-TYC) and their assessment has been considered in the attached report. Where a different amount is recommended to the amount sought by the group, to ensure compliance with the grant guidelines, this is outlined in the attachment under Comment and Recommendation. A summary of all applications is outlined below:

- Swan Districts Football Club are seeking funds to run their 'V Swans' program for Indigenous students at Eastern Hills Senior High School.
- Mundaring Arts Centre are seeking funds for UP in the Hills Art for teens program which will see a variety of arts based workshops run in local schools. All work will be exhibited at the Darlington Arts Festival and displayed at other community events.
- Eastgate Church are seeking funds to pay a staff member to update the Youth Services Registry that was previously updated by Seen and Heard. This will be distributed to all community groups and available online for anyone to access.
- Darlington Theatre Players are seeking funds for their Marloo Youth (MYTh) program for workshops and equipment required to produce a play in 2020.

The program proposed by Swan Districts Football Club (SDFC) aims to reengage students, improve behaviour and develop important personal and life skills, helping break the cycle of disengagement and increasing social connection to community. Suitably trained, skilled and qualified staff will deliver the program through guided support, mentoring and the successful V Swans 'Active Education' framework.

Activities will include, but not be, limited to:

- Health and Nutrition
- Team Building
- Art
- Competitions based on team building and creative thinking.

5. Community Consultation/Benefit

Young People (12-18yrs)

Swan Districts Football Club (SDFC) have not consulted with Aboriginal students specifically at Eastern Hills Senior High School (EHSHS), however SDFC have consulted with Aboriginal participants in their current 'Make Your Mark' program. Throughout this program SDFC have conducted a personal reflection and feedback survey, which has allowed them to collect data on many different aspects of the program, the impact and the outcomes associated directly with the participants.

Through this feedback process SDFC have established what has worked, what hasn't worked and whether or not the students would participate in the program again. This feedback provided data on which SDFC can make recommendations for the students themselves.

Should SDFC be successful in obtaining this grant, consultation with the students will be undertaken before rolling out the project. This will ensure that SDFC target their needs and establish clear outcomes for the program. This will create a holistic program for all involved.

Other community members who have been consulted regarding this proposed project are; Shire of Mundaring, Swan Districts Football Club - Youth Advisory Committee & Swans Aboriginal Advisory Committee, KOYA Aboriginal Corporation, Midland Police, Kiara Police and Midland District Leadership Council

The overall consensus was that this is a good program and that it should be funded. The Youth CREW (TYC) feel it is a good opportunity for the young Aboriginal students at Eastern Hills Senior High School to feel more included and engaged.

The V Swans program ran in other locations, has had great success with the young people who have been involved and comes highly recommended. Seeing positive outcomes EHSH approached SDFC to run this program.

4. Brief Description of Project

Mundaring Arts Centre is seeking funding support to deliver a series of quality, artist led workshops and projects designed to engage youth aged 12 -18 years from the Shire of Mundaring in a range of art activities to build skills and social connection. Schools to be involved include: Eastern Hills Senior High School, Mt Helena Primary School, Helena College, and Mundaring Christian College Senior School.

The environmental focus running across the Mundaring Arts Centre's program in 2019 presents a unique opportunity to engage professional artists to facilitate workshops for young people (Year 6 students to high school) in a diverse range of mediums including ceramics, fibre/textiles, drawing and painting from nature, electronic media, sculpture and printmaking.

The project will provide opportunities for young people to see their work presented professionally to the whole community through exhibitions, performance and festivals. These festivals will include What On Earth (WOE) 'Seeds, Pods and Pollen' community exhibition, 'Worn Out Worn Art' (WOWA) wearable art parade and interactive art activities at the Darlington Arts Festival including Indigenous carving and wood skills.

5. Community Consultation/Benefit

Young People (12-18yrs)

The workshop series has been designed after assessing the past activities undertaken by young people through the Mundaring Arts Centre program. There was strong interest in Indigenous arts, environmental themes, animation, three dimensional construction, ceramics and fibre art.

Through the Shire's and Mundaring Arts Centre's (MAC) youth projects, the Mundaring Environmental Art Project and WOWA, a large group of young people have developed a relationship with MAC, volunteering their time and demonstrating their passion for environmental topics. Many previous participants continue to assist in a volunteer capacity for large scale community events and open days such as the Darlington Arts Festival, Icon Projects such as What On Earth and through the school holiday program. Volunteers and young people involved in the public programs have expressed a desire to have more opportunities to exhibit their work to the public.

The Mundaring Arts Centre has an established record of attracting predicted participation in visual arts projects. The artists (Ross Potter, Narayani Palmer, Lee Woodwock, Mel Dare, Claire Bushby, Sarah Zel Chescoe, Angela Ferolla, Jennifer Cochrane, John Mogridge, Lea Taylor) and schools (Eastern Hills Senior High School, Mt Helena Primary School Year 6, Helena College, Mundaring Christian College Senior School) and community groups (Mundaring and Hills Historical Society, Katharine Susannah Prichard Writer's Centre, Men's Shed, Mundaring Sharing and Eastern Metropolitan Regional Council) outlined in the proposal have confirmed their support.

MAC has received feedback from teachers, students and individuals to indicate there is strong support for MAC arts projects and workshops.

11. Event Budget

The total budget is \$19,350.00. The applicant is seeking \$10,000.00 from Shire of Mundaring, being 51.6% of the budget.

12. Youth Advisory Group – The Youth CREW (TYC) comments

The Youth CREW (TYC) discussed this project extensively and have a few areas of concern. Their feedback is as follows:

They raised that the workshops being proposed will possibly be attended by students who do not necessarily wish to participate, as this has been their experience of school based activities, in order to make up numbers. They feel that when this happens the young people do not take the workshops seriously and therefore the funding would be wasted on them. They recommend that MAC do an Expression of Interest survey allowing them to see how many young people would actually be interested in attending or they suggest perhaps running the workshops during after school hours.

13. Community Engagement Facilitator – Youth comments

Historically Mundaring Arts Centre run well thought out and organised programs. The opportunity to attend workshops in this program will be available to many young people due to the number of schools involved. The workshops will be facilitated by numerous experienced artists. The program meets all of the objectives in the guidelines of the Youth Engagement Partnership Fund.

4. Brief Description of Project

To develop a directory of the services, programs, activities and support for young people in the Shire of Mundaring. This includes sporting groups, youth groups, recreational activities as well as health/mental health and wellbeing services and supports. The directory would be available in electronic format as well as hard copy and given to schools, teachers, chaplains, health professionals and youth workers and groups in the community. The directory would also act as a resource so groups are aware of other services and supports available to network and link in, fostering greater community partnership. The directory would also be available for young people to access directly, so they can access services and supports. This would be placed on social media sites and on our website (as well as other groups as permission is granted).

Items to be funded:

- Youth Coordinator wages 1 day/per week, over a 12 week period (including all on costs)
- Printing of directory
- Supervisor: Senior Pastor, 5 days over the 12 weeks
- Fuel allowance (a tank/fortnight)
- Additional workers compensation policy
- Office use computer, phone

5. Community Consultation/Benefit

Young People (12-18yrs)

Young people have been consulted who are engaged with Eastgate Youth and through work in the local schools and community. A common issue that is voiced by young people is that they are not aware of services in the community, or how to access them. Young people and their families often contact Eastgate Youth through Eastgate Church enquiring about what services are available in the community, and we have displayed some information in our community/youth room at Eastgate Church. Eastgate Church will also share information on local services through our Facebook page and young people engage with these posts.

Eastgate Youth attends health Expo's at schools and community events (not limited to the Shire but in other parts of Perth also) and have observed young people access information not only from Eastgate Church but other service providers, showing a need for this project. On discussion with young people at these events they share that they often don't know where to go for advice or information.

In our discussion with other community groups and organisations as well as schools, they have voiced a great need for this project, not being aware of the supports that are available for young people.

At the local Youthcare Eastern Hills District Council, where local school chaplains, church members and other community members attend, to support the work of school chaplains, the lack of awareness of local supports and services has been discussed, and the need for further resources in this area.

Outside of Eastgate Church, both Jared, who is the Senior Pastor for Eastgate Church and Lauren, who will be compiling the information for the directory, work in local schools and in the course of their work within these schools, have had people raise with them the need for this resource.

6. Access and Inclusion

Yes. The office space where the staff member is working provides accessibility for people with disability, including ACROD parking bay, ambulant toilet cubicle and ramp. The aim will be to contact all community groups that provide services to young people in the community, including CALD, and disability services. 4. Brief Description of Project

The Marloo Youth Theatre Program (MYTh) is an ongoing program which runs every Saturday from 2-4pm during school terms (38 sessions in total), run by five volunteer members of the Darlington Theatre Players at Marloo Theatre. The aim is to encourage our local youth to participate in all aspects of the performing arts and theatrical endeavour. MYTh are seeking funding to facilitate stagecraft training and to upgrade the sound and lighting infrastructure. Upgrading will provide technical training and enable large exhibitions and productions as a culmination of this program.

Items to be funded:

- Upgrade to Technical Equipment Sound Mixing Desk Behringer X32 Compact and SD 16 stage box
- Upgrade to Technical Equipment Laptop for sound operation
- Upgrade to Technical Equipment IPad for lighting operation

- Stage Combat Workshops X 3, 2 hour workshops
- Makeup Workshops @ 2, 2 hour workshops

- Craft supplies for Production and workshop work

5. Community Consultation/Benefit

Young People (12-18yrs)

MYTh consulted current members to see what projects they wished to engage with. This was done through the MYth end of year reflection session where the 2018 participants shared their strengths and weaknesses in the areas of Theatrical Endeavour and set goals for the 2019/2020 program. Upon verbal consultation, Leader Observations and these reflection sessions, it was ascertained that the young people wished to learn more about extending their performance skills in the areas of physical theatre and stage combat and learn how to apply makeup appropriately and creatively. The older members of the group (13-18 years) expressed a desire to learn more about the technical aspects of the theatre. After showing the participants the 'control box' at Marloo Theatre, they were fascinated to learn more about how to extend their skills technically. Unfortunately due to our audio and lighting infrastructure being inadequate, training could not happen at that time.

The community support for this program has been evidenced by an increased 'waiting list' for the program:

Once MYTh cleared the list early in March 2019, extra names were immediately added. Community members who have not been involved with Marloo Theatre or the Darlington Theatre Players previously have been contacting us via the web-site to see if they are able to add their child to this waiting list. Currently MYTh are at capacity of 25 participants. As word of mouth spreads about our program, this demand is expected to increase. Currently MYTh have had to let community members know that there is no space, which is a clear indicator that the MYTh program is supported by the community.

6. Access and Inclusion

Marloo Youth Theatre is accessible by any young people aged 12-18, provided we have the space for them to participate in the program. Three of the leaders of the program are Secondary Teachers and one is a Primary School Teacher. The fifth member works in a school environment. As such, the leaders have highly effective, tried and tested scaffolding and instructional strategies that enable them to deliver the program to include all learning styles and types and learning disabilities.

Participants in the proposed program have already been screened for their capacity to engage in the proposed activities and have found them to be suitable. Specific risks pertaining to each area of the proposed program will be addressed during the program, prior to the commencement of each activity. MYTh team leaders (Four of whom are qualified teachers and one of which is an experienced technician who also works in a school context) will be present throughout all activities undertaken by outside providers.

The total budget is \$9952. The applicant is seeking \$9552 from Shire of Mundaring, being 96% of the budget.

12. Youth Advisory Group – The Youth CREW (TYC) comments

The Youth CREW (TYC) felt the funding of new equipment didn't really meet the guidelines as it wasn't specifically for the young people attending MYth and would be for Marloo Theatre as a whole. They were wondering if there was another source of funding which may be used for this. TYC were also concerned that the program can only currently accommodate 25 members and this limited the number of young people who would be able to benefit from the funding.

13. Community Engagement Facilitator – Youth comments

The Marloo Youth Theatre program meets all of the objectives of the Youth Engagement Partnership Fund. This program serves to meet the needs of young people in the community who wish to pursue their interests in many areas of theatre/stage craft including skills which are transferable such as training in lighting and sound. Marloo Theatre are currently discussing extensions to their theatre building which would allow MYth to accept more members. Use of the Youth Centre has also been suggested. The purchase of minor equipment allows the young people who are members of MYth to be trained in these areas. The purchase of the headset microphones will assist in the performances by the young people into the future.

That a Youth Engagement Partnership Fund Grant to the value of \$9552 be awarded to the applicant.
