5.0 PRESENTATIONS

5.1 Presentation on Fire Clean-up and Recommendations

Rene Baur, Manager Building Assets provided the meeting with a presentation on fire clean-up learnings and recommendations, focusing on the more recent events in Harvey/Waroona and surrounds during which time he was seconded as Project Manager to work with contractors and residents through the demolition and clean up process.

5.2 Seasonal Review

Jamie O'Neill, Chief Bush Fire Control Officer provided the following:

- CESM had a meeting with RISE network who has replaced Home and Community Care (HACC) to discuss high-risk community groups within the Shire of Mundaring, recommending an invite to next LEMC meeting.
- Shire is currently in Prohibited burning period

- First multi-agency fire November 20 2017 in Greenmount, fire got to approximately 6ha before being bought under control. Agencies attending were Shire of Mundaring BFB, City of Kalamunda BFB, Park & Wildlife, DFES, Fire & Rescue and SES.
- Brigades have attended a number of fires in recent weeks, 4 of which have been suspicious.

Jamie O'Neill advised that the Shire had held its annual Test Your Bushfire Survival plan via Facebook on Wednesday 29 November 2017.

7.4 Funding Nominations and Applications Progress

Craig Cuthbert told the meeting that Minister for Emergency Services had released a Media Statement advising of a \$15 million bushfire mitigation fund being made available for 15 high-risk local governments to carry out mitigation works. Unfortunately, the Shire of Mundaring was not on the list to receive any funding.

Craig Cuthbert told the meeting that the Shire's Fire Hazard Inspection Officers are currently doing firebreak assessments with 7000 inspection being carried out so far.

8.0 URGENT BUSINESS (LATE REPORTS)

Craig Garrett provided the following report:

- Western Australian Fire & Emergency Services Conference was held on 8-10 September 2017 at the Perth Convention & Exhibition Centre
- DFES Regional staff have inspected UCL/UMR lands re mitigation works required for fire season. A number of prescribed burns were completed with the assistance of Brigades and fire break upgrades will be commencing shortly.
- DFES 2017 Volunteer Employer Recognition Awards(VERA) were held on 3 November 2017.

- DFES currently undertaking a project to replace the Computer Aided Dispatch (CAD) system which is used to dispatch resources for emergencies state wide.
- The State Bush Fire Exercise was held on 17 October. This year it involved the SOC/MOC and Regional incident management teams in country areas such as Northam and Manjimup.
- DFES staff attended onsite meetings with Acacia and Wooroloo prisons regarding pre-season arrangements and exercises.
- DFES have launched a new community engagement initiative, Fire Chat which
 replaces the Prepare Act Survive program. The Fire Chat will still be supported
 by the "Are You Ready" campaign, but will provide a series of short questions to
 guide the public into planning for fires and a range of tools to assist. Details are
 available on the DFES website. The 'Are You Ready' campaign was re- launched
 on Sunday, 1 October 2017.
- The Pre-season Bush Fire forum for volunteers was held by DFES at Joondalup on 4 November 2017.
- A Rural Urban Interface (RUI) exercise was conducted at Chidlow, in Mundaring Shire on 21 October 2017, involving BFB's and DFES VFRS and SES volunteers.
- A DFES Metro "Exercise Kaala" was held on 11 October 2017 involving fire and government agencies, invited LG's and other lifeline stakeholders, focussing on recovery following a major incident.
- The Westplan Fire has now transitioned into State Hazard Plan-Fire
- The DFES Season Synopsis has been released for this Fire and Cyclone season.
- Mr Darren Klemm is the new FES Commissioner.
- Thanks to the Shire of Mundaring, Parks and Wildlife and all emergency service volunteers for their support and assistance over the past year.

Claire Silveira

Provided the following report of activities from 31 August 2017 to 30 November 2017 :

1. PREPAREDNESS

- Our Natural Disaster Resilience Program (NDRP) funded 'Whole of Community
 Emergency Preparedness Project' continues to roll out. We are working with partners
 Shire of Nannup, City of Swan and City of Rockingham over the next six months with
 the aim to increase community resilience and emergency preparedness through training
 and education sessions aimed at vulnerable community groups, schools, community
 service organisations, local businesses and sporting clubs.
- Australian Red Cross has also released the first version of the new Preparedness APP "Get Prepared" (currently only available from Apple through iTunes) go to https://itunes.apple.com/au/app/get-prepared/id1292194053?mt=8

2. RESPONSE

- Volunteer training and scenario exercising has begun ahead of the upcoming summer across a number of Red Cross Emergency Services volunteer functions. One of our capacity development focuses this year will be volunteer leadership.
- The two day Response exercise 'Exercise Growth' was successfully delivered to over 50 volunteers in the Metro and 2 days in Busselton areas, incorporating a better understanding of AIIMS roles and training, Evacuation Centre training and a focus on Register. Find. Reunite.

3. REGISTER.FIND.REUNITE.

 Online training is now available to local governments, Department for Communities staff and Red Cross volunteers. Anyone interested in having access to the online portal, please contact Erin Fuery, State Manager Emergency Services (details below).

4. RECOVERY

- WA Police, on behalf of the SEMC Public Information Reference Group (PIRG), has been successful in receiving an NDRP grant to progress a 'Recovery Communication' project, working closely with Local and State Government on recovery communication gaps and opportunities. Red Cross is sitting on the Project Advisory Group, and ran training for PIRG members and members of the Advisory Group on Communicating in Recovery in mid-October.
- The independent evaluation of our recovery work across the shires of Waroona and Harvey continues. The aim of the independent evaluation is to assess the relevance, appropriateness and effectiveness of our recovery work in response to the bushfire; identify ways to strengthen the value of our contribution to community recovery processes; and make recommendations for improvement. The second round of consultation is about to begin. Summary findings from the midterm independent evaluation report include:
 - o Red Cross psychosocial support activities are strongly relevant and very appropriate to the needs of the community in recovery.
 - o Red Cross listens and responds to the needs of the community and individuals in recovery and supports them to drive their own recovery.
 - The information and assistance provided by Red Cross is appropriate and appreciated by stakeholders and the community.
 - There is opportunity to explore increasing partnerships with local community groups and organisations.
 - Red Cross recovery program promotes community connectedness, provides useful information and referrals to community members and builds capacity to help communities drive their own recovery.
- Volunteers, with coordination from the Red Cross Recovery Project Officer based in the Harvey Bushfire Recovery Hub, conducted Outreach to fire impacted residents in the Shires of Harvey and Waroona. Several Outreach events were held from September to November. A total of 1041 residents were provided with information and support from Red Cross volunteers.

5. VOLUNTEER ENGAGEMENT

- We have started to roll out our externally funded 'Building Regional Volunteer Capacity
 Project' with a 'Team Convenor' workshop held in Perth in early August. Volunteers from
 Kununurra through to Albany attended to share their knowledge, network, and upskill.
- Georgia Hay, a WA Red Cross Emergency Services volunteer, is one of five AIDR 'Resilience Ambassadors' across the country for 2017. Georgia is working with us on a project looking at volunteer leadership. More information can be accessed from the AIDR website: https://www.aidr.org.au/

6. NATIONAL ACTIVITIES OF INTEREST

- Red Cross Emergency Services in South Australia has developed Climate Ready
 Communities A Guide to Getting Started to support local governments and
 communities to have their own conversations about how the things they value will be
 impacted by climate change, and what they can do to continue to thrive. For more

- In early August, Red Cross ran a two-day workshop in Melbourne with recovery stakeholders from across the country. With support from AIDR, attendees from community, not-for-profits and all levels of governments workshopped issues and

- challenges in recovery to guide future national priorities. Feedback from this workshop will be available via the AIDR site soon.
- In early September, the WA Emergency Services State Manager represented Australian Red Cross at the Pacific Red Cross Societies Disaster Risk Management Forum held in Nadi, Fiji. The purpose of the Forum was to develop a unified approach for the Pacific national societies, working together with the same long-term goals, and to enhance the capacity of Pacific national societies allowing efficient and effective response and recovery efforts during an emergency. The Forum was facilitated by the International Federation of Red Cross and Red Crescent Societies (IFRC). The IFRC has numerous resources available for emergency services practitioners interested in accessing guidelines and research on practical humanitarian approaches to emergencies: http://www.ifrc.org/en/what-we-do/disaster-management/
