8.0 PENDING ITEMS

8.1 Fire Siren/Community Alert/Warning Siren

Draft guidelines have been distributed to local governments by OEM, with some comment received from local governments, which will be put together and distributed in due course.

Some LG's who have had communities keen to take on sirens. As a result of that a working group (off LEMC) has formed to address various issues around community sirens.

8.2 Animal Welfare Sub Plan

The draft Animal Welfare Sub Plan has been submitted to OEM.

8.3 Childcare Sector Engagement

Shire staff to make contact with Camp Australia and invited them to the next Principals Network Forum.

9.0 URGENT BUSINESS (LATE REPORTS)

Adrian Dyson told the meeting that the Economic Regulations Authority is currently review the ESL and has produced a report containing recommendations around how the ESL is distributed/spent, noting in the report that some portion of the ESL should be spent on planning and prevention, rather than just response.

Ryan Hamblion – Department of Communities

The Department for Child Protection and Family Support has now amalgamated with Community Grants, Funding & Initiatives, Disability Services Commission, Housing Authority and Regional Services Reform to form the Department of Communities. Additionally, when referring to the Department it can be also referred to as Communities after being referred to in the first instance as the Department for Communities and DC can be used when an acronym is needed.

14th June, 2017 - Held an Introduction to Welfare Centre Management at the Cannington Leisureplex. Attendees where walked through the stages of DC and LGA's management of a welfare centre. 36 attendees from LGA's, DC and other key stakeholder non-government departments attended.

19th July, 2017 - Held an Introduction to Welfare Centre Management at the Cannington Leisureplex. Attendees where walked through the stages of DC and LGA's management of a welfare centre. 42 attendees from LGA's, DC and other key stakeholder non-government departments attended.

Next training session will be held in September in the Armadale District and employees from the Mundaring LGA and other LEMC members are more than welcome to attend to get a greater understanding of the welfare support services offered during and after an emergency. The more LGA staff that are trained in working in the welfare centre will greatly assist the LGA with business continuity by having more trained staff being able to operate in the welfare centre.

Craig Garrett - District Officer North East

The State Bush Fire Exercise will be conducted in September 2017- TBC The State Earthquake Exercise will be conducted on Saturday 19 August 2017 The WA Fire and Emergency Services Conference to be held 8-10 September 2017.

DFES currently running Wintersafe Campaign targeting Storms and Home fire safety.

New CESM/CBFCO Jamie O'Neill commencing 31 July.

DFES will be inspecting UCL/UMR lands for mitigations works, prior to the southern fire season.

Two new light tanker fire vehicles supplied to Shire brigades, Parkerville and Glen Forrest BFB's from LGGS funding.

2017 Preparedness and Capability Survey

The survey closed on 14 June 2017. Office of Emergency Management is currently collating all information provided by local governments and hazard Management agencies. It is anticipated the 2017 Preparedness Report will be published the last quarter of the year.

Flooding in Western Australia: January and February 2017

Day Labour Exemption: Local Governments to be fully reimbursed.

The Commonwealth Government has confirmed that they will accept Western Australia's proposal to allow local governments to include overhead costs when using their own resources to undertake recovery works following a proclaimed disaster event.

This is excellent news for local governments as it enables them to be fully reimbursed when using their own labour for recovery works.

The previous Day Labour Exemption (9 May 2017) did not allow local governments to be **fully** reimbursed when using their own labour, as only salaries could be reimbursed. Now overheads, such as vehicle expenses, insurance and sick and holiday pay are covered.

It is important to note:

This **temporary exemption** can only be utilised for events occurring since January 2017. Repairs to damage caused by prior events should already be well underway, given the damage is to an essential public asset. Main Roads and OEM will, however, review specific local government requests for prior events on a case by case basis.

An important requirement for this exemption is that all local governments demonstrate the cost-effectiveness of using their own labour, plant and equipment, compared to contractors.

Local governments must claim overheads in accordance with the local government legislation and the Australian Accounting Standards.

Changes to the Temporary Framework

Since the release of the Temporary Exemption framework and supporting templates, OEM has worked with users to review the documents and further streamline the process. The <u>Supporting Guidelines and Templates</u> on the OEM website have been updated. Guidance on the specific overheads can be found in the <u>WANDRRA Guidelines</u>.

Assurance Directorate

Rationalisation of the Westplans

Work on Phase 7

Westplan Rationalisation is underway. This phase involves transforming all Westplans into State Hazard Plans and making them annexes to the overarching State EM Plan. The new State Hazard Plan template is near completion and will be circulated to stakeholders soon.

Westplans for similar hazards will be combined into a single State Hazard Plan during this phase. A workshop has been held to progress amalgamation of the four 'crash' related Westplans (air crash, road crash, PTA rail crash and Brookfield rail crash).

The Department of Fire and Emergency Services (DFES) has also been progressing the amalgamation of Westplans for the hazards of flood, cyclone and storm, as well as earthquake and collapse. Phase 7 is expected to be completed by December 2017.

Risk Assessment Reports

A risk assessment report has been produced for each of the Emergency Management districts in the state. These reports detail the results of the district risk assessments that were conducted as part of the State Risk Project.

Each report explains the risks posed to the district from a range of priority hazards. A credible worst-case scenario for each hazard was assessed in a workshop setting to determine the risks. Participants assessed how the hazards may impact upon the district's economy, its people, public administration, the environment and the social setting. These five key areas are part of the State Core Objectives.

The collective district data represents the culmination of three years of extensive n that has included input from 406 individuals from 119 separate agencies. The State Risk Project has identified the district level as the best avenue for practically assessing risk, developing treatments and measuring capability. These reports provide a body of evidence that shows how emergencies will likely affect us. This will then inform mitigation options and expenditure priorities to build a more resilient state.

10th Australasian Natural Hazards Management Conference (ANHMC)

The conference will be hosted by the Office of Emergency Management and will take place from 30 October to 3 November 2017. This year's conference will provide a forum for discussion of the integration of hazard information into effective emergency risk management. Applying science and research information to best practice planning, warning, response and recovery capabilities will lower the impact of events on communities. The conference will bring together expertise from Australia, New Zealand and abroad to enable the sharing of knowledge and strengthen collaboration. The target audience of the conference is: emergency managers, planners, risk assessors, asset and utility managers, natural hazard researchers and scientists.

WA Police - Recovery Communications Project

The SEMC Public Information Reference Group (PIRG) Chair Neil Stanbury has written to local governments requesting feedback in relation to how local governments would benefit from having access to any of the following support options during the recovery phase of an emergency:

- A network of media and public information specialists to provide advice and support to LGA media / communications staff;
- 2. Access to senior WA Government agency media / communications managers to provide advice on state-level coordination and facilitation of public information; and
- 3. Templates and guides to assist LGA media / communications staff in recovery communications.

Mr Stanbury is also interested in hearing any other suggestions or proposals that relate to how local governments could be supported at a state level in relation to the planning and delivery of recovery related public information activities. Local governments who wish to provide feedback on this matter, are asked to provide the information by Friday 15 August 2017. Please be advised Inspector Rob Harrison has replaced Mr Stanbury as the Chair of PIRG effective Monday 3 July 2017.

Memorandum of Understanding (MOU)

The Metropolitan South District Emergency Management Committee have been working on a draft MOU between all local governments in the south district including surrounding shires of Serpentine Jarrahdale and Boddington. The MOU will provide the opportunity to share resources through response and recovery. There is the possibility that the MOU could be progressed to the East, Central and North metropolitan DEMCs at a later date.

DEMC Chairs and Deputy Chairs Forum 27 June 2017

This year's theme is "Collaborative Leadership in Practice. The forum will discuss future emergency management planning, challenges of leadership in a changing environment and exercising.

The WA Police and DFES personnel are the Chairs and Deputy Chairs of the District Emergency Management Committees and will travel from around the state of Western Australia to attend.

WA Emergency Risk Management Local Government Handbook

The handbook is intended specifically for use by local governments around the State to facilitate risk management and to develop emergency management plans. Local governments are encouraged to view the handbook on OEMs website.

2016-17 NDRP Grants - announced

The Hon Michael Keenan Member of Parliament, Minister for Justice announced the successful projects for the 2016-17 grants on Thursday 15 June 2017. There were 41 applications requesting over \$2.8 million.
