## 6.1 PROPOSED NEW STANDARD MEETING ITEM – JOINT PREPAREDNESS PROJECT

The Executive Officer outlined the programme of activities for this project, saying that Red Cross have received a NDRP grant to fund a mult-year preparedness project with the City of Swan, Shire of Mundaring and City of Kalamunda.

#### 6.2 STATE EXERCISE COORDINATION TEAM (SECT)

The Executive Officer provided an update on the activites of the SECT, saying that from 2020 (on a 3 year cycle) all State Exercises will need to comply with the State Exercise Framework. The Shire of Mundaring's School Principal Network Forum have indicated that they would like to see an exercises around what happens at a school when it is treatened by a bushfire.

#### 6.3 SOM STAFF RECOVERY TRAINING

The Executive Officer outlined the contents of proposed recovery training to be delivered to SoM staff, advising that Shire of Mundaring staff may be required to carry out tasks outside of their normal duties during recovery (as many experienced in the Parkerville/Stoneville/Mt Helena fires in 2014). All staff will be required to attend a recovery training session which will be held during the month of October 2019.

The Executive Officer provided the meeting with an update on the joint Local Government Local Level Risk Workshops conducted to date, saying that Local Governments need to

get involved and do risk management/risk assessments around 4/5 key risks relevant to their location/environment. Shire of Mundaring have recenlty done a hazmat scenerio. It is expected that the next exercise will be around extreme weather with a report going to the SEMC once all workshops have been held.

### Australian Red Cross Emergency Services LEMC Update

Detailing activities July - September 2019

#### 1. PREPAREDNESS

- 'PERTH HILLS PREPAREDNESS PROJECT': Australian Red Cross has received an NDRP grant to fund a multi-year preparedness project with the City of Swan, Shire of Mundaring and City of Kalamunda. The comprehensive preparedness program will be guided by multi-agency steering committees to identify target groups, coordinate key messages, and advise throughout the project.
- 'PILLOWCASE' PREPAREDNESS SESSIONS FOR COMMUNITY & CHILDREN: Red Cross has been recruiting and training new volunteer Pillowcase presenters to deliver sessions in primary schools over the second half of the year. In 2018/19, volunteers delivered to 2056 students in the Metropolitan and South West Regions. Across July September, 675 students will attend Pillowcase lessons.
- RESILIENT AUSTRALIA AWARDS: The 'Whole of Community Preparedness Project', a
  collaborative project between Australian Red Cross, Shire of Nannup, City of Rockingham and
  City of Swan, received a Highly Commended at the Resilient Australia Awards (WA) ceremony
  held in July. Congratulations to all involved.
- RED CROSS PREPAREDNESS WEEK: Disaster Preparedness Week runs from Monday 23 September to Sunday 29 September. The main theme is; You can't stop disasters or emergencies from happening, but you can reduce how much they affect you. Take action now to prepare yourself and those you love for whatever may come your way. Red Cross will have an extensive media and promotional campaign and are asking stakeholders to share this information. Red Cross resources such as the Get Prepared App and Rediplan will be promoted.

#### 2. RECOVERY

 RED CROSS RECOVERY TRAINING PROGRAM: Australian Red Cross has begun to roll out recovery training across WA. Training was delivered in Bunbury and Perth in August and September to local government and state government representatives.

We are delivering three different recovery training programs, Community Recovery Training for Local Governments, Psychological First Aid and Communicating in Recovery Training:

**COMMUNITY RECOVERY TRAINING FOR LOCAL GOVERNMENTS:** With a focus across short, medium and long term recovery the training explores the physical and psychological challenges which affected communities may face after a disaster. Full of activities and discussion opportunities, the training will provide you an opportunity to consider practical aspects of community recovery whilst networking with fellow recovery workers. The training is augmented by a desktop discussion exercise.

**PSYCHOLOGICAL FIRST AID (PFA):** PFA is an approach to helping people affected by an emergency, disaster or traumatic event. It includes basic principles of support to promote natural recovery. This involves helping people to feel safe, connected to others, calm and hopeful, access physical, emotional and social support, and feel able to help themselves. PFA is recognised as international best practice early intervention psychological support provision following an emergency. The principles of PFA are an important grounding for all emergency personnel responding to an emergency.

COMMUNICATING IN RECOVERY TRAINING: Australian Red Cross 'Communicating in Recovery' training is now available for local governments, state government agencies, community groups and other stakeholders involved in community recovery. The 'Communicating in Recovery Guidelines for Local Government', produced by the State Emergency Management Committee's Public Information Reference Group is based on Red Cross resources.
